AN ORDER REORGANIZING THE CITY OF IMUS SAVE MANILA BAY TASK FORCE

WHEREAS, 2008 Decision of the Supreme Court en banc ordered the government agencies to clean up, rehabilitate, and preserve Manila Bay, and restore and maintain its waters to SB level to make them fit for swimming, skin-diving, and other forms of contact recreation.

WHEREAS, 2011 Supreme Court Resolution on informal settlers and illegal encroachment DPWH and LGUs of Cavite, Laguna, Rizal, etc., shall submit the names and addresses of the informal settlers in their respective areas who as of September 30, 2010 own or occupy houses, structures, constructions and other encroachments built along the Imus River, and the Laguna de bay, and all other rivers connecting waterways, and *esteros* that discharge wastewater into the Manila Bay in breach of Republic Act No. 7279 and other applicable laws;

WHEREAS, DILG Memorandum Order issued on June 5, 2011, re: "taking notice of the continuing mandamus" Order of the Supreme Court, and in keeping with the constitutional-legal mandate for the state and local governments to manage and maintain ecological balance in accord with the harmony and rhythm of nature, all concerned City Mayors and *Punong Barangays* are enjoined to take in, and to regularize the cleaning-up of "esteros", rivers and other waterways within their jurisdictions that exit into the Manila Bay.

WHEREAS, this Order shall serve as an **ADDENDUM** to Executive Order No. 21 Series of 2022;

NOW, therefore, I, ALEX L. ADVINCULA, Local Chief Executive of the City of Imus, Province of Cavite, by virtue of the powers vested upon me by law, do hereby order the creation of the City of Imus Save Manila Bay Task Force with the following provisions:

Section 3. Duties and Functions- The City of Imus Save Manila Bay Task Force shall have the following duties and functions:

- a. The City of Imus Save Mnaila Bay Task Force shall supervise all field activities, monitor compliance to prescribed Key Performance Indicators (KPIs) and submit quarterly progressive reports to the KPIs to DILG Provincial Office.
- b. The Monitoring Team shall serve as the inventory and Inspection Team and shall directly interact in the field, perform actual inspection and gather necessary and relevant data, using the DILG Key Performance Indicator Capture Forms 1 and 2.

Section 7. Effectivity- This Executive Order shall take effect immediately upon the approval hereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
